It is with great pride that I present my report as Chair of BBAMZ Ltd for 2022/23.

The board welcomed Rachael Andrews from East Arm Resources during the year, and I thank Rachael for taking up the challenge and for bringing her expertise and experience to our board of directors. The board now comprises two female and four male directors. Inclusion and diversity are key planks of BBAMZ and our plan is to have the board of directors reflect that.

Our CEO Susie Bower has developed a team within BBAMZ and NEBHub where five of the eight team members are women – reflecting a focus on skills brought to the organisation rather than just equal gender representation.

The Northern Employment Business Hub, (NEBHub) continues to be an outstanding success, led by NEBHub General Manager Nicole Grose. In May this year the whole team took the time to reflect and celebrate on these achievements. The team was joined by many of the businesses and community leaders who have contributed to NEBHub, including the Minister for Skills and Employment, the Hon. Felix Ellis, who acknowledged the Tasmanian Community Fund for its initial grant to get the initiative started and an opportunity for BBAMZ to thank the Tasmanian Government for ongoing funding. The real reward was hearing about 300 people being placed in employment in twelve months. I would strongly encourage all BBAMZ members to use this free service to help your business find your next new employee.

The Board recently held a strategic plan review session, and it is pleasing to report that all goals had progressed, and some had exceeded the plan. This has prompted a review of BBAMZ's future focus over the next five years. This of course is not a decision for the board alone; it needs members' input and I thank all members who participated in the recent survey. BBAMZ is now a recognized peak organization, meaning the BBAMZ voice, on members' behalf, is heard loudly where it counts.

I am pleased to present the Annual Report for 2022/23. As a membership-based organisation committed to fostering sustainable growth and prosperity for Bell Bay and the Tamar region, we want to share our accomplishments and challenges that have contributed to the region's economic progress.

BBAMZ have worked in partnership with TasPorts to have an operational presence back in Bell Bay. BBAMZ is now located at 1 Mobil Road in Bell Bay, sharing the building with TasPorts. It is a fantastic location and BBAMZ is very appreciative to TasPorts for making it possible. As the renewables sector expands in Bell Bay it is a perfect location for others to join BBAMZ and Tas Ports to create a functioning renewables hub.

BBAMZ has dedicated significant time engaging with numerous businesses to showcase the potential benefits of establishing their business in Bell Bay. This work is time consuming and doesn't always show results immediately, but we are setting the foundations up for the future and I am optimistic that some of this work will see results on the ground over the next 12 months.

As we work towards the implementation of the Hydrogen Hub as one of the consortia partners, former Minister for Energy, Minister Barnett agreed to extend the funding for the Bell Bay Hydrogen Manager until June 30 2024. The Minister has always understood the importance of having industry lead development of Hydrogen in Bell Bay. This allowed certainty for that role as we plan for the next three to five years where BBAMZ will concentrate on Industry Capability, Workforce Development and Community Engagement within the hydrogen industry.

BBAMZ is continuing to work in collaboration with education providers to highlight the career options and workforce needs of the Bell Bay area. BBAMZ successfully partnered with Tas Tafe to receive funding to implement the Certificate II in Renewable Energy, which has specialisations in hydro, solar, wind and hydrogen. This qualification is the first in Australia for the renewables sector and we look forward to contributing to the content to make sure the qualification is fit for purpose for industry.

Due to the enormous success of the Northern Employment and Business Hub, BBAMZ achieved an extension of funding until September 30 2024. NEBHub celebrated achieving over 300 job placements in this financial year where Minister Ellis attended to recognise the achievement. NEBHUb is continuing to excel in placing local people in local jobs and training opportunities throughout the Northern municipalities of George Town, West Tamar, Launceston, Flinders Island, Meander Valley, and Northern Midlands under the leadership of our General Manager Nicole Grose.

I am very grateful for the unwavering support of our members as your contributions play a pivotal role in the success of our programs and the resources you provide help us to make a positive impact in the communities where we do business. I would like to thank the Board and in particular BBAMZ Chair Leigh Darcy for their continued support and trust in me to lead the organisation. Media Coverage


BBAMZ continues to generate significant media coverage across all platforms, including online, television, radio and print media.

Industry Capability and Workforce Planning Strategy

BBAMZ, with support from RECFIT, developed the *Industrial Capability and Workforce Development Strategy* for the prospective hydrogen industry at Bell Bay. This report lays the groundwork for future planning for skills augmentation from existing trades skills to those required for the production and use of hydrogen and its derivatives.

Following on from the Supply Chain Map BBAMZ developed in 2021, the Industry Capability work undertaken in the report indicated that, as a whole, manufacturing and service industry businesses in the Bell Bay zone will continue to adapt their existing business models to achieve ongoing alignments to any new markets or industries that are developed at Bell Bay.

Industry Skills Compact Advanced Manufacturing

BBAMZ is a member of the Advanced Manufacturing Workforce Advisory Group, which comprises Tasmanian Minerals, Manufacturing and Energy Council, the Tasmanian Agricultural Productivity Group and the Tasmanian Maritime Network.

This group delivered the *Industry Skills Compact Advanced Manufacturing*, which presents a common understanding of key priorities and challenges relating to skills and workforce development in the advanced manufacturing sector in Tasmania.

The compact identifies priority actions that could be advanced collaboratively for the benefit of Tasmanian business and industry.





The Bell Bay Green Hydrogen Hub

BBAMZ, through the extension of the grant from the Tasmanian Government has continued to progress the emerging hydrogen industry in Tasmania. Bell Bay was announced as a preferred site for an export-scale green hydrogen hub in 2021, which was reconfirmed by the Federal Government in 2022. RECFIT has been working with the Bell Bay Green Hydrogen Hub Consortium Partners and the Federal Government to progress the grant deed which will facilitate the delivery of the hub.


BBAMZ, as a consortia partner, will be key in the development of workforce planning, community engagement and industry capability. BBAMZ's strong links to local business and community will allow the hub's potential to be fully developed, not just as an export-scale manufacturing site but to also facilitate the development of smaller scale production for the local usage of hydrogen in transport and manufacturing sectors.

While the focus of Bell Bay is across many different industry sectors, the development of hydrogen production capacity will positively influence investment decisions as businesses merge into the hydrogen supply chain economy. BBAMZ members ABEL Energy, Woodside Energy and Countrywide Hydrogen are actively progressing their projects.

The Industry Capability Network

BBAMZ has worked closely with the Tasmanian Government supported Industry Capability Network to develop the Tasmanian Green Hydrogen Supply Chain Directory. This directory will link Tasmanian businesses to the construction and operation of any new renewable energy project in this state.

The Directory will be a key tool for hydrogen proponents as they develop supply chains for the manufacturing of green hydrogen and its derivatives such as green methanol and ammonia. The Directory will also be a key source to identify what businesses seeking to engage in the green hydrogen industry will be able to offer.



CEO Ministerial Liaison

BBAMZ CEO Susie Bower continues to advance the interests of BBAMZ members through regular connections with Tasmanian ministers and their senior advisory staff.

Additionally, the CEO maintains excellent working relationships with the elected Tasmanian members for Bass, Rosevears and Windemere and Federal members and Senators where appropriate – all of whom have a key interest in the further development of the Bell Bay Industrial Zone.

Successful Grant Applications

BBAMZ was successful in receiving an extension of funding from the Tasmanian Government for the Hydrogen Capability role, critical for the ongoing industry capability and workforce skills development work at Bell Bay.

Additionally, BBAMZ successfully applied for and received funding for the Youth Connectors program, which provides for better support for young people across the communities that NEBHub operates in.

The development of specific qualifications in the emerging hydrogen industry has been underway for several years, with the Certificate II in Renewable Energy the first of such qualifications to be certified. BBAMZ has established a partnership with TAFE Tasmania for the delivery of this course, the practicalities of which will be developed during 2023/24.

BBAMZ Member Meetings and Business Breakfasts

BBAMZ has continued to hold the very popular Members Meetings, where the membership and involved stakeholders gather to hear from potential new developers in Bell Bay, current Bell Bay businesses seeking to expand and service providers of interest to Bell Bay enterprises.

The NEBHub team have been working in collaboration with Searson Buck's Job Ready Fund and VXT short courses, where we have provided over 100 job seekers access to funds and courses to upskill and enter into the workforce. BBAMZ and the NEBHub team value the strong collaboration and partnerships that contribute to such a successful program.

We would also like to extend a sincere thanks to the NEBHub steering committee, Barb Parker, Steve Simeoni, Jemma Mackinnon, Fiona Miller and Shane Power for your dedication and guidance throughout the year - together we are making a positive difference for businesses and for job seekers.

Notes to the Financial Statements

BBAMZ Ltd

For the year ended 30 June 2023

The financial statements are for BBAMZ Ltd as an individual Company, incorporated and domiciled in Australia. BBAMZ Ltd is a Company limited by guarantee.

Note 1 - Statement of Significant Accounting Policies

Basis of Preparation

These financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Australian Charities and Not-for-Profits Commission Act 2012. The directors have determined that the not-for-profit Company is not a reporting entity.

The financial statements have been prepared on an accruals basis and is based on historical costs modified by the revaluation of selected non-current assets, financial assets and financial liabilities for which the fair value basis of accounting has been applied.

The following specific accounting policies, which are consistent with prior period unless otherwise stated, have been adopted in the preparation of these financial statements. Where items have been reallocated between line items in the financial statements, comparative figures have been reallocated accordingly to ensure comparability is maintained.

Accounting Policies

A) Income Tax

BBAMZ received charity endorsement by the Australian Charities and Not-for-profits Commission on 1 October 2022 and has been approved for the following tax concessions

- GST Concession
- Income Tax Exemption
- FBT Rebate

B) Trade and Other Receivables

Trade receivables and other receivables are recorded at amounts due less any allowance for doubtful debts. Bad debts are written off during the period in which it becomes apparent that the amounts will not be recoverable

C) Property, Plant and Equipment

Property, plant and equipment are carried at cost or at fair value, less, where applicable, any accumulated depreciation and impairment losses. The carrying amount of property, plant and equipment is reviewed annually by the Directors to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the fair value of the assets less cost to sell or the depreciable replacement cost of these assets.

Depreciation

The depreciable amount of all fixed assets are depreciated on a straight line basis over their useful lives to the Company, commencing from the time the asset is held ready for use.

The depreciation rates used for each class of depreciable assets are:

D) Employee Benefits

Short Term Employee Benefits

Provision is made for Company's obligation for short term employee benefits, Short term employee benefits are benefits that are expected to be settled wholly within 12 months after the end of the annual reporting period in which employees render the related service, including salaries and annual leave. Short term employee benefits are measured at the amount expected to be paid when the obligation is settled.

Long Term Employee Benefits

The Company classifies employees' long service leave and certain annual leave entitlements as long-term employee benefits as they are not expected to be settled wholly within 12 months after the end of the annual reporting period in which the employees render the related service. Provision is made for the Company's obligation for long term employee benefits.

The company's obligation for long term employee benefits is recognised as part of non-current provisions in the Statement of Financial Position unless the Company cannot defer settlement for 12 months they they are classed as current provision.

E) Revenue

Government funding and other grant revenue is recognised in the period in which the services funded by the grant are to be provided by the Company. Where grants are received that relate to future period, that portion of the grant is recognised as a liability on the Statement of Financial Position.

Revenue from the provision of membership subscriptions are recognised in the financial year to which the subscription relates.

F) Good and Services Tax

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquistion of the asset or as part of an item of the expense. Receivables and payables in the Balance Sheet are shown inclusive of GST.

G) Provisions

Provisions are recognised when the company has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that an outflow can be reliably measured. Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

H) Critical Accounting Estimates and Judgements

The Directors evaluate estimate and judgments incorporated into the financial report based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and with the Company.

Key Estimate - Impairments

The company assesses impairment at each reporting date by evaluating conditions specific to the company that may lead to impairment of assets, When an impairment trigger exists, the recoverable amount of the asset is determined. Value in use calculations performed in assessing recoverable amount incorporate a number of key estimates.


